



RESOLUTION AND NOTICE OF ELECTION
PURSUANT TO N.C.G.S. §§ 160A-104 AND 163-287

**A RESOLUTION CALLING FOR A SPECIAL ELECTION
TO VOTE ON AN ORDINANCE AMENDING THE TOWN
CHARTER OF THE TOWN OF SUMMERFIELD TO
CHANGE THE FORM OF GOVERNMENT FROM
COUNCIL-MANAGER TO MAYOR-COUNCIL**

WHEREAS a Petition to amend the Town Charter of the Town of Summerfield, pursuant to North Carolina General Statute § 160A-104 and certified by the Guilford County Board of Elections, was presented to Council at the July 13, 2010 Council Meeting; and Council accepted same and called for a Special Election, pursuant to North Carolina General Statute §§ 160A-104 and 163-287; and

WHEREAS an Ordinance amending the Town Charter to change the form of government of the Town of Summerfield to a Council-Manager form of government, as defined in North Carolina General Statute § 160A-147 *et seq.*, was adopted on January 1, 2008, following a vote of the people; and

WHEREAS the Town Council of Summerfield, in accordance with North Carolina law, wish to put this issue to the voters of the Town of Summerfield for adoption or rejection of this Ordinance in a Special Election.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF SUMMERFIELD, GUILFORD COUNTY, NORTH CAROLINA, THAT THE PETITION TO AMEND THE TOWN CHARTER FOR THE TOWN OF SUMMERFIELD FROM A COUNCIL-MANAGER FORM OF GOVERNMENT, IN ACCORDANCE WITH NORTH CAROLINA GENERAL STATUTES §§ 160A-101(9)b AND 160A-147, *ET SEQ.*, TO A MAYOR-COUNCIL FORM OF GOVERNMENT, IN ACCORDANCE WITH NORTH CAROLINA GENERAL STATUTES §§ 160A-101(9)b AND 160A-155 *ET SEQ.*, SHALL BE PUT TO A VOTE OF THE PEOPLE. THE FORM OF THE BALLOT SHALL BE AS SET FORTH IN NORTH CAROLINA GENERAL STATUTES § 160A-105; AND

BE IT THEREFORE FURTHER RESOLVED THAT UPON A VOTE OF THE PEOPLE TO AMEND THE TOWN CHARTER FOR THE TOWN OF SUMMERFIELD FROM A COUNCIL-MANAGER FORM OF GOVERNMENT TO A MAYOR-COUNCIL FORM OF GOVERNMENT, COUNCIL SHALL PASS AN ORDINANCE AMENDING SAME; AND

BE IT THEREFORE FURTHER RESOLVED THAT THE GUILFORD COUNTY BOARD OF ELECTIONS SHALL CONDUCT THIS SPECIAL ELECTION AT THE SAME TIME AS THE REGULARLY SCHEDULED ELECTIONS HELD ON THE FIRST TUESDAY FOLLOWING THE FIRST MONDAY IN NOVEMBER OF THE YEAR 2010.

THE PROPOSITION TO AMEND THE TOWN CHARTER FOR THE TOWN OF SUMMERFIELD SHALL BE PRINTED ON THE BALLOT IN SUBSTANTIALLY THE FOLLOWING FORM:

“SHALL THE ORDINANCE TO AMEND THE TOWN CHARTER FOR THE TOWN OF SUMMERFIELD TO CHANGE THE FORM OF GOVERNMENT FROM A COUNCIL-MANAGER FORM OF GOVERNMENT, IN ACCORDANCE WITH NORTH CAROLINA GENERAL STATUTES §§ 160A-101(9)b AND 160A-147, *ET SEQ.*, TO A MAYOR-COUNCIL FORM OF GOVERNMENT, IN ACCORDANCE WITH NORTH CAROLINA GENERAL STATUTES §§ 160A-101(9)b AND 160A-155 *ET SEQ.*, AND ANY CHARTER PROVISIONS NOT IN CONFLICT THEREWITH, BE APPROVED?”
