STAFF RECOMMENDATIONS/COMMENTS

SPARC has worked to develop new programming for the Summerfield Community Park. A grant opportunity has been found that could fully fund an arts program that utilizes the Summerfield Community Center for youth acting workshops and the Amphitheater for up to three small-scale theater events. A letter of intent was submitted February 27. If the UAC is interested in our proposal a formal grant application will need to be approved by Town Council before submission. The letter of intent is attached for your review. The proposed grant does not require any matching funds. The request is for approx. \$26,000. This opportunity to provide a program sponsored by the Town but at no cost to the Town appears to be a win-win for the Town and the United Arts Council efforts to expand beyond Greensboro. The grant is for one fiscal year, but can be renewed.
