AN ORDINANCE AND RESOLUTION PROVIDING THAT ORDINANCES AND ACTIONS HAVING THE EFFECT OF ORDINANCES OF GUILFORD COUNTY SHALL BE APPLICABLE WITHIN THE TOWN AND JURISDICTIONAL LIMITS OF THE TOWN OF SUMMERFIELD, EXCEPT AS OTHERWISE SPECIFIED

**Ordinance and Resolution Providing that Ordinances and Actions Having the Effect of Ordinances of Guilford County Shall be Applicable Within the Town and Jurisdictional Limits of the Town of Summerfield, Except as Otherwise Specified**

**WHEREAS**, pursuant to the laws of North Carolina, the governing body of a City or Town may allow county ordinances to be applicable within the City or Town limits; and

WHEREAS, on July 2, 1996, the Town Council of Summerfield passed Ordinance Number 1996-001 providing that all ordinances of Guilford County and actions having the effect of Ordinances of Guilford County be applicable within the Town and jurisdictional limits of Summerfield to the same extent as applicable within the unincorporated areas of Guilford County; and

**WHEREAS**, the Town has lawfully enacted Ordinances controlling certain subject matter as specifically enumerated in each Town Ordinance.

**WHEREAS**, in any instance where both the Town of Summerfield and County of Guilford have promulgated Ordinances that address the same subject matter, then and in that event, the Ordinance promulgated by the Town shall be controlling and be given a preemptive and preclusive effect over the competing or corresponding ordinance promulgated by the County of Guilford.

**WHEREAS**, in any instance where the County of Guilford has promulgated an Ordinance addressing a particular subject matter and there is NO corresponding or competing Ordinance promulgated by the Town of Summerfield, then, and in that event, the Ordinance promulgated by the County of Guilford shall control.

**WHEREAS**, following Public Hearing in this date and vote of Council, Town Ordinances numbers 1996-001, and 1999-004 have been repealed and it is the intent of the Summerfield Town Council that this Ordinance and Resolution shall replace Ordinance 1996-001;

**NOW, THEREFORE, BE IT ORDAINED AND RESOLVED** by the Town Council of the Town of Summerfield as follows:

Section 1. Town Ordinance and Resolution 1996-001, and Ordinance 1999-004 are hereby repealed and 1996-001 is replaced by this Ordinance.

Section 2. Except as specifically promulgated by Summerfield Ordinance, all of the Ordinances and actions of the Board of County Commissioners of Guilford County having the effect of Ordinances shall continue and remain in effect within the incorporated and jurisdictional limits of the Town of Summerfield, and shall be as fully applicable and enforceable within the Town and jurisdictional limits as in the unincorporated areas of Guilford County.

Section 3. This Ordinance and Resolution shall be effective as of January 11, 2012, and shall remain and continue in effect unless or until amended or repealed by the Town Council of Summerfield.
